Strawberries (field cropping only)	Scarab beetles (Scarabaeidae)	440 g/100 m row

## **Critical Use Comments:**

- Apply during bed forming prior to planting
- DO NOT make more than one application.
- Apply by Precision Granular Boom applicator and immediately cover with mulch to ensure product remains within the target area and is not available to birds.

# Withholding Period:

Not required when used as directed.

#### **Jurisdiction:**

QLD only.

# **Additional Conditions:**

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

The holder of the permit must notify the APVMA of new information, including relevant information in accordance with section 161 of the Schedule to the Agricultural and Veterinary Chemicals Code Act 1994, in accordance with the obligation imposed by that section.
