**PERMIT TO ALLOW MINOR USE OF A REGISTERED AGVET CHEMICAL
PRODUCT FOR CONTROL OF WHITE WAX SCALE IN BLUEBERRIES**

PERMIT NUMBER – PER91301

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Product to be used:

MOVENTO 240 SC INSECTICIDE (APVMA No. 61864)

Containing: 240 g/L SPIROTETRAMAT as the only active constituent.

Directions for Use:

Crop	Pest	Rate
Blueberries (Field and Protected)	White wax scale (<i>Ceroplastes destructor</i>)	40 mL product / 100 L

Critical Use Comments:

- Monitor crops during early spring to late summer. Commence applications at the onset of the crawler emergence stage¹ or when pest numbers reach economically damaging levels.
- Apply as a dilute foliar spray using an airblast micronair or boom spray.
- Use a spray volume of 1400 L water/ha.
- Apply thoroughly to ensure complete coverage.
- DO NOT apply more than three (3) applications per season, at a minimum 14 day retreatment interval.
- Apply with spray adjuvant *Hasten* at 50 mL/100 L spray tank mixture.
- *Movento* may have adverse effects on predatory mites where IPM is practiced.

Note 1. There are usually two crawler release stages with the second emerging in mid to late summer. If the first generation is not adequately controlled or persists then a second spray can be applied in late summer.

Withholding Period:

Harvest: Do not harvest for 7 days after application.

Grazing: Do not graze treated crops.

Jurisdiction:

All States and Territories, except VIC.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.
